CONTRACT

This Contract for the Procurement of One-Way Flight Tickers for the Members of the Nightingales for the Commemorative Events of the 127th Anniversary of the Proclamation of Philippine Independence ("Contract") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** of 80 Hoenamu-ro, Yongsan-gu, Seoul 04346 represented by Ambassador Maria Theresa B. Dizon-De Vega, herein referred to as Embassy, and **ABC WORLD TOUR** of 355-15 Itaewon-dong, Yongsan-gu, Seoul represented by Mr. Oscar Amboy, herein referred to as Company.

I. Scope of Work

The Company agrees to reserve and make necessary arrangements for the one-way flight tickets of the members of Nightingales traveling from Dhaka, Bangladesh, to Seoul, ROK, via Incheon.

II. Flight Reservations

According to the requirement of the Embassy, the Company shall reserve the flight tickets with the following specifications:

III. Rebooking and Cancellation Fee

If the Embassy wishes to rebook or cancel the confirmed flights, the Company shall charge the Embassy applicable rebooking or cancellation fees, in accordance with the airlines' rules and regulations. Computation of the said fees is as follows:

- a. 15 to 30 days before scheduled flight – KRW 120,000 ~ KRW 140,000
- b. Less than 15 days before scheduled flight – KRW 140,000 ~ KRW 160,000
- c. Within 24 hours / No Show Penalty – KRW 240,000 ~ KRW 280,000

The final computation of applied rebooking or cancellation fees will depend on the actual date of the request for rebooking or cancellation of the specified flight tickets or itineraries.

IV. Terms of Payment

Payment shall be made within seven (7) days after fulfillment of the contract and upon receipt of invoice. The Embassy shall deposit the payment to the Company's bank account with the following details:
